

COVID travel guide for mainland Portugal

ENTRY REQUIREMENTS:

FOR CUSTOMERS TRAVELLING FROM THE UK	
To enter the country you will need to show:	
1. That you are fully vaccinated against COVID AND 2. That you have received a negative COVID test result before arrival.	<p>You will need to show that you have been fully vaccinated at least 14 days prior to travel. Full information from the Portuguese authorities can be found here.</p> <p>Either a PCR Test taken within 72 hours of travel, OR a lateral flow/antigen test taken within 48 hours of travel are accepted. Free NHS tests are not accepted; please use a private testing provider. More information on this is available here.</p> <p>For more details on testing and private providers, please refer to this guide.</p>
Before arrival you will need to:	
<ul style="list-style-type: none"> Fill out a Passenger Locator Card to register with the Portuguese authorities. 	<p>The Passenger Locator Card can be completed by going here</p>
Upon arrival you will:	
<ul style="list-style-type: none"> Show evidence of your vaccination status and negative test result. Undergo a temperature check. 	<p>Please ensure you have the correct evidence/certificates with you before you depart.</p> <p>If your temperature is 38°C or over, or if you show symptoms of being unwell, you may be required to take a further COVID test and remain at the airport until the test results are received.</p>
While in Portugal you will:	
<ul style="list-style-type: none"> Show evidence of full vaccination OR having received a recent negative COVID test to check into some accommodation, and be permitted entry into some restaurants/bars or other public venues/events 	<p>Your NHS COVID Pass for Travel will be accepted as evidence for these. We advise having a PDF copy of this on your phone/device, and a printed copy with you throughout the trip for this purpose.</p> <p>If you have not been fully vaccinated please contact our Customer Operations team at your earliest opportunity to discuss what options may be open to you.</p>

48 hours	<input type="checkbox"/> Complete your UK arrivals Passenger Locator Form (link here)
48 hours	<input type="checkbox"/> Check in online & expect to supply copies of entry documentation
Return home	<input type="checkbox"/> Show your entry documents to UK immigration
Up to plus 48 hours	<input type="checkbox"/> Take your 'on or before day 2' PCR test
Plus 48 hours	<input type="checkbox"/> Share your PCR results with UK government
