

COVID travel guide for Madeira

ENTRY REQUIREMENTS:

FOR CUSTOMERS TRAVELLING FROM THE UK	
To enter the country you will need to show:	
<ul style="list-style-type: none"> That you are fully vaccinated against COVID OR <ul style="list-style-type: none"> That you have received a negative COVID test no more than 72 hours before arrival. 	<p>The NHS COVID Pass for Travel is accepted to demonstrate your COVID vaccination status. For more information please click here.</p> <p>This must be a PCR Test. Free NHS tests are not accepted; please use a private testing provider. More information on this is available here.</p>
Before arrival you will need to:	
<ul style="list-style-type: none"> Register online with Madeira authorities 	<p>This is done by going here</p> <p>The online form will ask you to create an account, and for details on where you wish to take your Return to Home test. Not everyone returning to the UK will need to do this; it depends on your vaccination status and country of residence within the UK. If required, this field is completed after arrival in Madeira, so please leave it blank and make a note of your log-in details. If you do not require a test before you return to the UK please still leave the field blank.</p> <p>Upon completion your information is submitted to the local authorities, who will review it. Once this has been done you will be provided with a QR Code. Please note that these are reviewed individually, so there may be a wait for this to come through.</p> <p>While on the trip you will be sent an email with a 5 digit code, which allows you to book a free COVID test prior to departing Madeira, should you need to do so.</p> <p>Your Exodus tour leader will give more details on how this works during your trip; should you require any assistance please ask and they will be happy to help.</p>
Upon arrival you will:	
<ul style="list-style-type: none"> Show evidence of your vaccination status OR negative test result Show the QR code to demonstrate you have registered with the Madeira authorities 	<p>Please ensure you have the correct evidence/certificates with you before you depart.</p>

	<input type="checkbox"/> Complete the online registration form with Madeira authorities
48 hours	<input type="checkbox"/> Check in online & expect to supply copies of entry documentation

On departure	<input type="checkbox"/> Show copies of your NHS COVID Pass and Passenger Locator Form to airline staff at check-in/at the gate
Return home	<input type="checkbox"/> Take your COVID test(s) – either day 2 only or day 2 and day 8 (depending upon your vaccination status/country of residence)
